Notice is hereby given, that Oak Marsh LLC will receive sealed bids in response to Solicitation <u>#2019-OAKM-02</u> for the project known as *Oak Marsh Precast Concrete Wall*. This solicitation is for the building permitting, construction and installation of a precast concrete perimeter wall. This work shall be installed at Timber Ridge at Sanders Pines located at 2449 Sanders Pines Circle, Immokalee, Florida. Funding for this project is provided by the U.S. Department of Housing and Urban Development (HUD) HOME Program and Collier County Division of Community and Human Services.

All sealed bids are to be received no later than 2:00 PM, Thursday, August  $22^{nd}$ , 2019 at Timber Ridge at Sanders Pines Office located at 2449 Sanders Pines Circle, Immokalee, FL 34142. 


## **Timber Ridge at Sanders Pines Precast Concrete Wall**

Oak Marsh LLC requests sealed written bids for a precast concrete wall to be installed at its Sanders Pines rental community located at 2449 Sanders Pines Circle, Immokalee, FL 34142. Funding for this project is provided by the U.S. Department of Housing and Urban Development (HUD) HOME Program and Collier County Division of Community and Human Services. This work includes the following:

- The work consists of providing all labor, equipment, supplies, material, transportation, handling, storage and performing all operations necessary to complete the construction of the precast concrete wall.
- The work also consists of preparing all requisite plans and obtaining all necessary permits including permit fees from Collier County, FL. Survey information shall be provided to the Contractor by Owner.
- The installed wall includes three sections along the northern property line. Total linear feet is estimated at 580 +/- LF.
- The installed wall shall be painted using Sherwin-Williams SuperPaint Exterior Acrylic Latex or equivalent.
- Contractor shall be responsible for the removal and disposal of existing chain link fence 580 +/-LF.
- Fence construction specifications are shown in the attached PDF drawing. The attached site plan illustrates the northern perimeter location. The contractor shall include a linear foot cost in its bid to be used to adjust final installed length.
